Keynote Speaker

Jacob's career has been with Merrill Lynch in Pismo Beach, CA and then Morgan Stanley in Vancouver, wherein he currently manages his own practice with JP Morgan Wealth Management, as a Private Client Advisor. With his many clients throughout the Pacific Northwest, from both his previous job roles and experience in the Military, he uses his wealth of knowledge and expertise to focus on long term strategies and is also working on his Masters in Finance.

It was his mother's faith, determination and involvement, which developed him into who he is today, as well as the care he received from his community and his experiences in the military.
